Re: Revision in various Employee Benefits

We have been informed by GIPSA that the Governing Board of GIPSA have approved the revision in the following employee benefits:

- (i) Revision of Housing Loan
 - A. Revision in Loan Limits
 - B. Reduction in Rate of Interest on Scheme Loan & Supplementary Loan
- (ii) Revision in Vehicle Loan Schemes for Employees with Administrative Role
- (iii) Revision in Lease Rent Limits for Residential Accommodation (Applicable for Scale VI & VII)
- (iv) Revision in Limits of Lodging Charges to employees while on Official Tour
- (v) Revision in Out-of-Pocket expenses to Officers for attending Lok Adalat/ Conciliatory Proceedings on Holidays
- (vi) Revision in Limit of Reimbursement of Expenses for Transportation of Household Goods on transfer for Employees.
