We would like to bring to your kind notice that General Insurance Pensioners All India Federation is registered under Trade Union Act. We comply with the provisions under the act of auditing our accounts, holding Executive Committee meetings, maintaining minute's book, membership register and submitting the copy of all to the Registrar of Trade Union, Maharashtra, every year.

We at present have eight thousand plus members in pan India. Our All India Federation has eleven units all over the country affiliated with it.

As a largest Pensioners organization we naturally have the right to insist GIPSA to invite us for discussion when in service employees charter of demands will be discussed with major unions shortly.


In this connection we would like to state here that we have submitted our charter of demands in April, 2018 to GIPSA and four PSGI Companies as well as GIC Re. Some of our important demands are also included by major unions. Since some of our issues are to be discussed we accordingly feel our presence is also required to highlight in depth those issues before management.

We are of the opinion you should also introduce some mechanism to give recognition to Association like us which will help us to take up our issues with the management in proper platform. At present we get lukewarm response from GIPSA.

We expect you will consider our request and advice GIPSA to invite us at the time of wage negotiations with all major unions.
