Dear All Members,

9th General Body meeting of General Insurance Pensioners' Association Northern zone was held on 4.06.2022 at Scope Minar, Laxmi Nagar, Delhi. In memory of our late Chairman Shri JP Jain, auditorium was named as "J.P. Jain Auditorium".

Shri R.R. Singh, CEO, GIPSA was chief guest and Shri U. Banerjee, General Secretary of GIPAIF was special invitee.

Shri R.S. Tuteja, Chairman, GIPANZ welcomed dignitaries on dais and all members attending the meeting from different cities of northern zone. He also conveyed his message through a story and appealed to all members to do not only give suggestions but also come forward to support the Association calls.

Shri N.P. Upadhyay, President of association in his speech recalled how the Association was formed with only 11 members in 2009 and now our strength is more than 3,000 members today. He also recalled how the life changing achievements were obtained. He stressed that unity and strength is the key factors to resolves our issues. He also shared his past experience and history of struggles to fulfill the expectation of retirees.

Shri R.R. Singh ECO, GIPSA assured the house that GIPSA is working on issues with non financial impact on public sector general insurance companies. He also assured that ministry is working on wage revision and hope that shortly (within this month) next round of talks with check off Associations will resume. He also assured that doors are always open for the Association and GIPSA is positive to resolve the same which will affect them also after retirement.

Shri A.K. Singhal, Advisor also highlighted the issues related to retirees and how the GIPSA is working to resolve. He also informed the house about the issues particularly related to SVRS 2003 and 2004 and back ground of schemes.

Shri U. Banerjee, General Secretary, GIPAIF informed the house about the steps and efforts Association is putting to solve the issues. He also informed the house about the meeting with under secretary, ministry of finance, insurance division held on 03.06.2022 and progress in matters in related to increase in Family Pension and Pension option to TAC, LPA retirees.

As per Agenda minutes of last general body meeting held on 5th March 2020 were read out by Shri V.K. Sharma, Treasurer and the same unanimously confirmed by the house.

Shri Shyam Mathur, General Secretary, GIPANZ placed his Governing Body report highlighting the efforts made to achieve few pending demands. In his speech Mr. Mathur narrated the efforts put by the Association in discussing various issues with GIPSA and ministry. He also informed the house about discussion with authorities of HITPA for improvement in services, increase in PPN hospital, quick settlement of reimbursement claims etc. Governing body report was adopted unanimously by the house

Shri V.K. Sharma, Treasurer, placed the audited accounts of Association for the period 2019-2020 and 2020-2021 which were unanimously adopted by the house.

Shri Sharma informed the house that our present auditor M/s Dhuper & Company has surrendered his license hence he proposed a new auditor M/s Piyush Govil & Associates may be appointed for the next financial years with Rs 11,000/- remuneration plus taxes, if any. House has approved the proposal.
